What Vendors Should Know: Rules and Guidelines

1. All products need to be produced within 50 miles of Alamo Michigan. No manufactured, commercial or home party items will be allowed. The Market Manager reserves the right to reject an application, or ask any vendor to comply with these rules. Vendors who fail to comply will be asked to leave the market.
2. The Market Manager is in charge and makes decisions necessary for the functioning of the market during its hours of operation. Vendors are expected to abide by these decisions.
3. Registration and set up start at 7 a.m. the morning of the market. Vendor space location will be assigned by the Market Manger.
4. Payment is due with registration and is non-refundable. Please include a self-addressed, stamped envelope. You will receive a receipt as acknowledgment of your registration.
5. Vendors are responsible for their own table, chairs, scales, cool storage, and any other items you need.
6. Be courteous and do not begin to pack up before the market closes.
7. Vendors are responsible for their own sales tax.
8. Free standing canopies shall have no guy lines as people may fall over them. Vendors are responsible for any damage/injury caused by wind-blown canopies.
9. Vendors are responsible for clean-up and removal of all generated refuse and trash.
10. Vendors are responsible for knowing and complying with the rules for processed food items for sale, according to the MI Depart of Agriculture and Rural Development (MDARD. For more information:
